The Butts County Board of Education held its regular monthly School Board Meeting with the following members present: Millard Daniel, Mamie Crawford, Clifford Marshall, Bobby Craven, Kelly Strickland-Raney, Superintendent Todd Simpson, and members of the staff.

Millard Daniel called the meeting to order with the Pledge of Allegiance.

On a motion by Clifford Marshall, seconded by Kelly Strickland-Raney, the board unanimously 5-0 approved the agenda as presented. Said agenda is hereby made a part of these minutes by reference.

Their task was using computer coding to solve "real world problems" in a hands-on STEM experience. Each team performed well enough to qualify to move on to the Super Regional Competition. Both JES and SES teams have competed in the Super Regional at the Clayton State University, January 11<sup>th</sup>, and are moving on to the next round in Athens, GA, February 1<sup>st</sup>, 2020. DES will compete in the Super Regional in Warner Robins, January 25<sup>th</sup>. The board was very proud of our teams. A list of our team members will be placed in the minute attachment notebook.
